A regular meeting of the City of Hamilton Board of Aldermen was held on Wednesday, August 13, 2025, from 5:33 p.m. to 7:30 p.m. at City Hall, 200 S. Davis Street, Hamilton, Missouri.

- 1. Call to Order: Mayor Cole Crawford called the meeting to order at 5:33 p.m.
- 2. Pledge of Allegiance: Deedie Esry led those present in the pledge of allegiance.
- **3. Approve Agenda:** There was a motion by Robert Grant to approve the agenda. Toni Schmidt seconded the motion, and the board voted in favor.
- 4. Approval of Meeting Minutes July 9, 2025, Regular Meeting:

There was a motion by Deedie Esry to approve the meeting minutes from July 9, 2025. Toni Schmidt seconded the motion, and the board voted in favor.

- 5. Review and Approval of Bills: There was a motion by Deedie Esry to approve the bills. Toni Schmidt seconded the motion, and the board voted in favor.
- **6. Public Comment:** Bud Motzinger reported that he attended a meeting with Cole Crawford and Bob Hughes in St. Joseph last week.
- 7. D.A. Davidson: Steve and Brock with D.A. Davidson discussed selling the bonds for the street project. After discussion, there was a motion by Deedie Esry to sell \$1,500,000 (this amount includes any processing fees) in bonds. Toni Schmidt seconded the motion, and the board voted as follows: Cameron Fast aye; Robert Grant aye, Deedie Esry aye; and Toni Schmidt aye.
- 8. Bill No. 081125 Ordinance Amending Chapter 75 Article IV of the Hamilton City Code –
 Disposal of Grass Clippings First Reading: Cole Crawford read the first reading of Bill No.
 081125. There was discussion regarding yard waste and place to dump it. There was a motion by

Deedie Esry to open the old rodeo grounds for yard waste disposal and city staff to set up dates and times. Toni Schmidt seconded the motion, and the board voted in favor.

- 9. Bill Number 081225 Ordinance Setting Tax Levy for Property Taxes for Year 2025 First Reading: Cole Crawford read the first reading of Bill Number 081225.
- 10. Bill Number 081325 Conflict of Interest Policy First Reading: Cole Crawford read the first reading of Bill Number 081325.
- 11. Resolution Number 2025-16 Blue Shield Program: Chief Kirkendoll spoke to the board about the Blue Shield Program. There was a motion by Cameron Fast to approve Resolution No. 2025-16. Robert Grant seconded the motion, and the board voted in favor.
- 12. Police Equipment Requests: Chief Kirkendoll spoke to the board about equipment requests. There was a motion by Deedie Esry to purchase 2 Toughbooks for the police department vehicles. Robert Grant seconded the motion, and the board voted in favor.

There was a motion by Cameron Fast to purchase AXON body cameras and MULES (budget annually). Robert Grant seconded the motion, and the board voted in favor.

There was a motion by Cameron Fast to enter into a service agreement with Lexipol to update the police department policy. Deedie Esry seconded the motion, and the board voted in favor.
