Water, Sewer, Trash:

Utility billing through the City of Hamilton. ****see address and phone number above**** Office Hours 8:30 a.m. to 4:30 p.m. (M-F)

Water Deposit: is required for each meter.

\$200.00 – Residential Property Owners

\$150.00 – Commercial Business (trash is billed directly from R&W Container)

\$350.00 – Residential Rental Customers

\$15.80 – Trash deposit required residential

\$15.80 – 1st month's trash bill

Sewer charges are based on water usage.

Trash: pickup days are Tuesday, Wednesday, Friday depending on the location. Items that WILL NOT be picked up are: large appliances, tires, batteries, oil, yard waste, paint, and large furniture. It is recommended to use trash cans with lids to avoid destruction by animals. Trash cans must have handles and holes in bottom for drainage if there is no lid. Please bag all trash and place curbside.

City of Hamilton **utility bill is due on the 10th and Delinquent after the 20th of every month.** A \$30.00 late charge will be applied for delinquent accounts. There is a \$25 disconnection fee and a \$65 reconnection fee if services are disconnected due to non-payment. A drop box is located on the north side of City Hall for your convenience. Payment can also be paid by credit card on our website (www.cityofhamiltonmo.city).

Dog & Cat License: Due by July 1st of each year.
